### Caution Explanations

1 Player #5 North Medford charged into an opponent with no attempt to play the ball. This charge was performed in a careless manner (Rule 12.8, Art. 1, F.10) near the North Medford Penalty area (position 3b). DFK restart.  
The players name was not available due to the absence of rosters)



### Send Off Explanations

1 Player #9 South Medford is guilty of denying an obvious goal-scoring opportunity (Rule 12.8, Art. 2, d.3) (DOGSO). Player #9 South M. tripped an opponent moving quickly towards the South Medford goal with no opponents other than the goalkeeper between him and the opponent's goal. This was deliberate and occurred within goal scoring distance of the goal, around position 5b, outside the penalty area.
