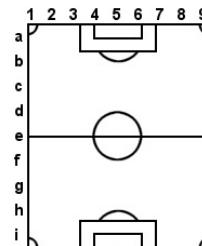

- 1 In the 51st minute #20 was dribbling the ball through the midfield in the d-3 area. A midfielder for SH made a sliding tackle from the side sweeping the ball away. In the process #20 fell over the midfielder legs. As both girls got to their feet, I could see the anger in #20 eyes so I close to within 3 yds of the players. As I got close, #20 grabbed the midfielder by the arm then took a swing at her face. The player lean back so the punch graised the side of her face. The ball was still in play, so I blew the whistle, issued the red card to #20 and she left the field. Play was restarted with an indirect to SH at the d-3 area.
