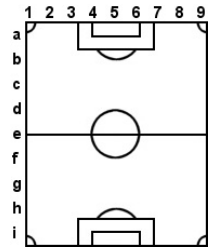

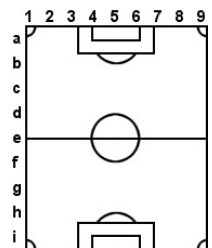

Caution Explanations

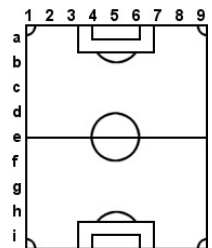
1 In the 17th minute of the first half, I cautioned Eddy Soboll, coach of West Salem, for unsporting behavior. Play was stopped for a foul committed by a West Salem player in front of the West Salem bench near grid point d1. Mr. Soboll began to protest the call. A South Medford player in the vicinity responded to Mr. Soboll's remarks by stating that he believed that it was a foul. Mr. Soboll responded directly to the player by saying, "You come into our house?" I stopped Mr. Soboll from saying anymore, cautioned him for unsporting behavior and showed him the yellow card. As play had been stopped for the foul, it was restarted with a direct free kick to South Medford.



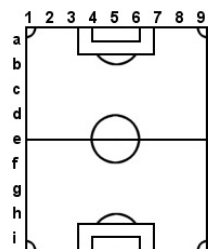

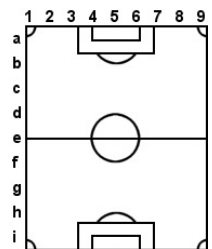

The incident took place near grid point f3. I cautioned Mr. Linares for Unsporting Conduct and showed him the yellow card.
