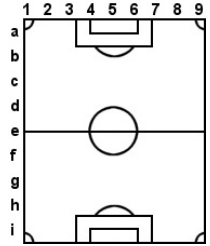

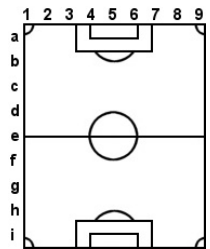
### Caution Explanations

- 1 In the 38th minute of the first half, Jose Saldana Alvarez, #15 of South Salem, recklessly pulled his opponent, Riley Fee, #17 of Crescent Valley, down from behind after he had lost possession of the ball to Mr. Fee. The incident took place near grid point b3. I cautioned Mr. Saldana for Unsporting Conduct and showed him the yellow card. Mr. Salana left the field per NFHS rules and was replaced. Play was restarted with a direct free awarded to Crescent Valley.



### Send Off Explanations

- 1 In the 38th minute of the first half, Riley Fee, #17 of Crescent Valley was fouled by his opponent, Jose Saldana Alvarez, #15 of South Salem. As he and Mr. Saldana were getting up from the ground. Mr. Fee kicked at Mr. Saldana in retaliation for the foul. The incident took place near grid point d3. I sent Mr. Fee off for exhibiting violent conduct and showed him the red card. Mr. Fee left the match and was not replaced. As play had been stopped because of the foul committed by South Salem, it was restarted with a direct free kick awarded to South Salem.
