### Caution Explanations

1 Player #17 Grants Pass (Woodward) charged into the back of an opponent dribbling the ball with no attempt to play the ball. The challenge was reckless and caused the opposing player's head to whip backward. The opposing player was not injured on the play, however the yellow card was shown to Woodward under Rule 12.8.1.F.10.



2 Player #22 North Medford (Mora) committed two fouls punishable by a DFK and one dangerous play resulting in an IFK, within the span of approximately 15 minutes after being warned of his challenges. Player was shown the yellow card under Rule 12.8.1b.



3 Player #17 Grants Pass (Woodward) struck an opposing player with his arm in the mid-section (stomach) of an opposing player after the ball had gone out of play for a Grants Pass thrown in at approximate position 9b in the Grants Pass defensive half. The two players were chasing the ball out side-by-side and when the ball left the field #17 (Woodward) swung the arm unnecessarily toward the opposing player striking him, but not seriously injuring him. Woodward was warned for similar behavior suspected, but not punished, in the 55th minute. Woodward is guilty of unsporting conduct per Rule 12.8.1.F.



### Send Off Explanations

1 Player #17 Grants Pass (Woodward) was dismissed from the field of play after receiving a second caution in the same minute per Rule 12.8.2.C.



### Serious injuries observed:

#4 North Medford (Rene Torres-Mata) collided heads with an opposing player and the coach was called onto the field to attend to the player in the 25th minute at approximately position 2f near the benches. Player did not lose consciousness, but was told check in the medical personnel.
