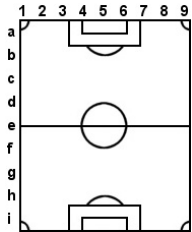

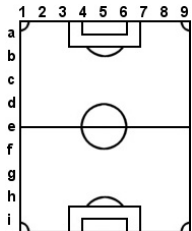

### Caution Explanations

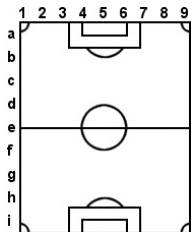
- 1 Summit was awarded a free kick in its attacking third at C8. The player came by the official and publicly stated "that was weak" then publicly repeated "that was soft." A variety of teammates had been verbally warned about dissent prior to this occasion, so the player was cautioned at this time. To his great credit, when he returned to the field he apologized and shook hands.



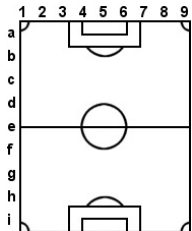
- 2 The player had committed a variety of fouls of the pushing and holding variety. On this occasion he pulled an opponent in possession of the ball to the ground without making a meaningful play on the ball in the middle third of the field. He was cautioned for persistent infringement.



- 3 This player had expressly been verbally warned after having committed two fouls earlier and for dissenting on a variety of calls. As his teammate was booked he approached and asked the reason, which was given as persistent infringement. He then started to argue with a comment that began "but.." and was cautioned for dissent.



- 4 A Summit player was in possession of the ball in his defensive half moving toward midfield at F7. The cautioned player was sprinting directly toward the Summit player and recklessly attempted to tackle the ball with a hard, cleats up slide. The ball was well away when the cautioned player made minimal contact with the Summit player. The caution was for a reckless, cleats up tackle. Had there been greater contact it would have been serious foul play. However, this was the player's second caution, so he was sent off with a red card subsequently.
