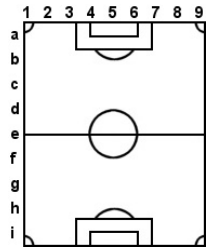

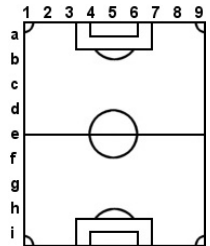

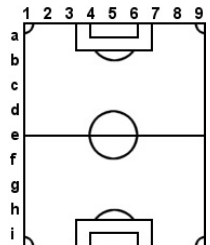
- 1 Player fouled opponent (@d7) as attacker dribbled ball through mid-field. Tactical foul. Fourth foul. JK 9/9/2015



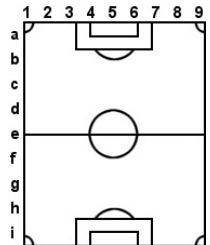
- 2 Keeper shouted at opponent to, "Shut up," after the ball was played up the field. JK 9/9/2015



- 3 Reckless challenge by IV player, pushing from behind, without making an attempt to win the ball (@e8). JK 9/9/2015

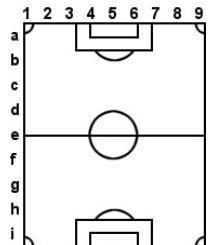


- 4 Reckless challenge on opponent (@c4). Shoulder in the back, no attempt to play ball. JK 9/9/2015
