
1 Player number 6 Joe rocker from jesuit high school was shown a yellow card for dissent on the 60th minute.

2 Head coach Chris Thurley from Jesuit High School was shown Yellowcard for dissent on minute 65.



Player number 5 attempting to challenge for the ball recklessly tackled an opponent unsuccessfully getting to the ball on time.


No injuries resulting from the incident player number 5 was sent off the field of play and was substituted for. The opponents were awarded a direct free kick
