

**Caution Explanations**

1 In the 20th minute of the first half, I noticed that Jasmine Rodriguez, #15 of McKay was wearing an earring covered by a bandage. At the next stoppage in play, when her team had kicked the ball into touch, I had Ms. Rodriguez leave the field to remove the earring. She was replaced. I cautioned Arturo Alfaro, head coach of McKay, because his player had illegal equipment. Play was restarted with a throw-in awarded to North Salem where the ball had been kicked out of play near grid point f9.



2 In the 5th minute of the second half, Amy DuVall, #5 of North Salem, recklessly charged her opponent off the ball as she was headed into her offensive third of the field. The incident took place near grid point c8. I cautioned Ms. Duvall for unsporting conduct and showed her the yellow card. Ms. DuVall left the field per NFHS rules and was replaced. Play was restarted with a direct free kick awarded to McKay at the spot of the foul.



3 In the 24th minute of the second half, Mercedes Garcia, #10 of McKay, a forward recklessly charged her opponent in an effort to win possession of the ball. The incident took place near grid point a1 in her attacking half of the field. I cautioned Ms. Garcia for unsporting conduct and showed her the yellow card. Ms. Garcia left the field per NFHS rules and was replaced. Play was restarted with a direct free kick awarded to North Salem at the spot of the foul.



4 In the 35th minute of the second half, I cautioned Carrie Ochoa, #22 of North Salem, for persistent infringement. Ms. Ochoa committed her third careless foul of the half by carelessly pushing her opponent in front of her. I had previously warned Ms. Ochoa against such careless play. The incident took place near grid point (g6). I cautioned Ms. Ochoa for persistent infringement and showed her the yellow card. Ms. Ochoa left the field per NFHS rules and was replaced. Play was restarted with a direct free kick awarded to McKay at the spot of the foul.



5 In the 29th minute of the second half, Amy DuVall, #5 of North Salem, engaged in unsporting conduct by delaying the restart of play. A foul had been called against Ms. Duvall near grid point g4. After the whistle, Ms. DuVall kicked the ball away from the immediate area of play. I cautioned Ms. DuVall for unsporting conduct and showed her the yellow card. Since it was Ms. DuVall's second caution, she left the field and was not replaced. Play was restarted with the direct free kick awarded to McKay at the spot of the foul (g4).



6 In the 30th minute of the second half, Jackie Maciel, #19 of McKay, engaged in unsporting conduct by delaying the restart of play. A foul had been called against Ms. Maciel near grid point b7. After play had been stopped, Ms. Maciel kicked the ball away from the immediate area of play. I cautioned Ms. Maciel for unsporting conduct and showed her the yellow card. Ms. Maciel left the field per NFHS rules and was replaced. Play was restarted with the direct free kick awarded to North Salem at the spot of the foul (b7).



7 In the 33rd minute, I cautioned Jasmine Rodriguez, #15 of McKay, for dissent. A foul had been called on Ms. Rodriguez? teammate near grid point c5. Ms. Rodriguez protested the call, continuing a pattern of prolonged dissent on the part of the McKay team. I cautioned Ms. Rodriguez for unsporting conduct and showed her the yellow card. Ms. Rodriguez left the field per NFHS rules and was replaced. Play was restarted with the direct free kick awarded to North Salem at the spot of the foul (c5).



**Send Off Explanations**

1 In the 29th minute of the second half, Amy DuVall, #5 of North Salem, received her second caution of the match. I showed Ms. DuVall the red card and sent her off. She left the field and was not replaced. Play was restarted with a direct free kick awarded to McKay for the foul committed by Ms. Duvall near grid point g4.
