Caution Explanations

1 I issued a yellow card for a reckless challenge on an Eagle Point player sweeping his feet from behind.



2 Issued a yellow card for repeatedly objecting to decisions of the officials. He repeatedly objected to the offside calls and despite being asked to be quiet and sit down he continued to dissent.






Send Off Explanations
