



### Caution Explanations



I called for the Gervais coach on the field and ask him to control his players and also their language. He had no clue to what I was talking about, he apparently did not hear his players cussing or yelling about me during the game. As Juan L. was shown a straight Red Card, ejected Gervais player Juan F. Navarrete entered the field without permission and started to say fuckin asshole, bitch to me. I told the coach to control his players and to not enter the field.



### Abnormal or unusual situations to report:
