



Caution Explanations

1 McLoughlin was attacking the north goal at C3 when the Sisters player made a clean slide tackle to clear the ball. However, in his follow through the Sisters player raised his extended leg to trip the McLoughlin attacker as he tried to hurdle the tackle. Sisters player was cautioned for the unsporting behavior and the game was restarted with a direct free kick for McLoughlin.



2 Sisters had been awarded a free kick. The McLoughlin player ran to stand directly over the ball and prevent a restart. His team had been previously warned about just such behavior and he was cautioned for unsporting behavior - delaying the restart. The game was restarted with the free kick which had originally been awarded.




As an aside, later in the game Sisters had to "ask for 10" and several McLoughlin players argued strenuously that you must ask for 10. My attempt to clarify the rule was unpersuasive.

3 This Sisters player has a comment for virtually every call that did not go Sisters' way throughout the match. In the 47th minute in response to a free kick awarded to McLaughlin he directed an exasperated "Jesus Christ" at the official. He was cautioned for dissent and the game was restarted with the free kick which had been awarded McLaughlin.



4 Sisters was in possession of the ball forming an attack toward the north goal at D3. The McLoughlin player charged the Sisters player in possession of the ball and knocked him to the ground without making a play on the ball. He was cautioned for unsporting behavior and the game was restarted with a free kick for Sisters at the spot of the foul.



Send Off Explanations

1 The McLoughlin player and Sisters #12 were competing physically, but fairly, for the ball at D1. As the Sisters player gained possession of the ball the McLoughlin player took a deliberate step to ensure a proper angle and maximum force and deliberately, intentionally and willfully kicked the Sisters player in the upper leg. He was ultimately sent off for violent conduct after order was restored and the card was issued. The restart was a free kick for Sisters.

Abnormal or unusual situations to report:

When the red card was issued in the 73rd minute there was brief chaos at the site of the foul. Sisters, especially #10 Malachy Sundstrom, aggressively approached the disqualified player in an attempt to support his teammate who had been kicked. Many players from both teams were chest to chest. AR2 had come on to the field to assist in restoring order, and since this occurred at D1 the fans were a potential issue as well, though the athletic director was right there to manage the fans. After 30 seconds or so Sisters players responded to my admonition to "go to your bench" and collectively, as a team, the Sisters players moved toward their bench at C9.

Meanwhile, the disqualified player was being restrained by his own teammates, and others of his team were arguing that he should only receive a caution and that I was only issuing a red card in response to fan reaction. Finally, #10 went to his bench, the players returned to their positions and the game was restarted. To McLoughlin's credit, the 4th official informed me after the game that the McLoughlin coaching staff ordered #10 to the team bus.
