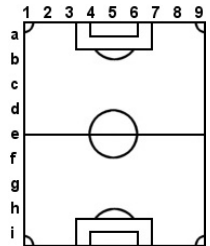
- 3 Player number 4 Josue Reyes from south Medford was given a yellow card for dissent on minute 62 of the match.
