Coach Jernberg is an assistant coach, I was the base umpire. With his team at bat in the 3rd inning, he was continually shouting out from the dugout in disagreement with ball/strike calls. Also, we had informed the Willamette pitcher that he needed to wait until the batter got his feet set in the box before he began to go to the set position. After the third time of his attempt to quick pitch to the hitter, the batter had hit a foul ball and legally stepped out of the box, Coach Jernberg yelled out to the plate umpire to make the batter stay in the box. I called time and told Coach Jernberg that as an assistant coach he is not allowed to address the umpires in an argumentative tone and only the head coach is allowed ask questions of clarification. He continued his arguing, so I asked the head coach to take care of Jernberg, to keep him quiet. He didn't, and Coach Jernberg continued to mouth off. I told him to be quiet and he kept up with his argument and I ejected him. He then charged out of the dugout and got up in my face and yelled some more profanities before leaving the field.
