I have thoroughly reviewed the Eligibility Request Form that has been submitted seeking a waiver of OSAA Rule 8.2 (Fifth Year). From the documentation that you have submitted I have concluded the following:

Findings of Fact:

1. Ariana first entered the 9th grade in September 2011 at Jesuit High School and her 4 consecutive years of eligibility expired at the conclusion of the 2014-15 school year.
2. Ariana has not graduated from high school. She has accumulated 41 credit hours thus far and still needs 10 credit hours to graduate.
3. Ariana was enrolled in school and received academic credit during each of her 4 years in high school.
4. Ariana has a gap in her academic record during two semesters due to complications from suffering two concussions. The first serious concussion occurred in December 2012 and she was unable to attend school during the second semester of her sophomore year. The second serious concussion occurred in September 2013 and after struggling academically, her doctors came to the conclusion to withdraw her from school for the second semester of the 2013-14 school year. Documentation from her doctors at Oregon Health & Science University details these two serious concussions and her diagnosis of Post Concussive Syndrome that resulted in forced withdrawal from school to focus on her complete recovery.





Tom Welter,

Jesuit is applying for hardship for Ariana Wiltjer for her to participate in athletics for the 2015-16 school year as a 5th year senior under rule 8.2.4. Her concussion and resulting learning and cognitive disability have kept her out of school for almost two full semesters at Jesuit, and so she is now a senior at Jesuit, though this is her 5th year of high school. In addition, Ariana only passed 4 classes last semester due to cognitive struggles, (currently only 3 are listed on her transcript because a teacher has not graded her summer make-up work, but it will be 4 soon). As such, we are also asking for a grade deficiency hardship under Rule 8.1.1. Ariana is on track to graduate as a starting senior at Jesuit having completed 41 credit hours (51 are required to graduate at Jesuit and 36 credit hours are needed under OSAA rules).

As the attached letters from the Wiltjer family and her doctor explain, Ariana participated (in a limited fashion due to hip injury) in Jesuit volleyball her freshmen and sophomore years at Jesuit. In December of her sophomore year, Ariana received a serious concussion. She withdrew from Jesuit for the second semester of her sophomore year. Starting her junior year, she re-enrolled at Jesuit and started participating in the volleyball program. Unfortunately, her symptoms returned and she withdrew from the volleyball program in mid-September. Academically, she limped through the first semester of school, but Ariana once again withdrew from Jesuit for the second semester. Missing two semesters of schooling, she returned for her 4th year as a junior, and now as a 5th year senior.

Given Ariana strong grades, her serious cognitive disability resulting in missing two semesters, we ask for a hardship for Ariana Wiltjer for this coming 2015-16 school year.

To whom it may concern:

As the parents of Ariana Wiltjer, we would like to present a Hardship Appeal 8.2.4 to allow her to participate in the 2015 Girls Volleyball season. Although she has NOT attended Jesuit 4 years yet because of her brain injury (she missed 2 springs semesters equaling a year), Jesuit has asked us to write this letter of explanation. The following is her history of play and attendance at/for Jesuit.

Her freshman year in 2011, during the beginning of fall, she was diagnosed with a hip impingement. She had to have hip impingement surgery after fall semester. She missed school but she was able to keep up with a tutor. She missed most of the regular season of volleyball but was able to play in the State Championship game.

Her sophomore year, in December 2012, Ariana received her first serious concussion at the Olympic Training Center playing volleyball. She was unable to attend school for the entire spring semester due to her symptoms, nor play club volleyball. In the summer of 2013, she was medically released to take two summer courses at Jesuit.

Unfortunately, in September 2013, during a Jesuit practice, before the regular season began, she sustained a direct hit to her head from a ball and received a second severe concussion. That semester, Jesuit accommodated her with longer test times and more help with reading, etc. to be able to complete the semester. She was unable to get better and suffered from post concussive syndrome. *She did not participate in any regular season volleyball game nor was allowed in the gym in the 2013 regular season.* Her doctors, in December, came to the

conclusion that she needed to completely withdraw from school in January 2014 from Jesuit for complete cognitive rest. She missed her second spring semester. She also was out for another club volleyball season.

Ariana spent the next six months at home; sleeping, no exercise, limited mental stimulation (computer, phone, TV) with therapy learning how to deal and manage her post concussive syndrome. In June 2014, she was released to start exercising for the first time and had manageable headaches. She had also been medically released to begin academics starting in the fall of 2014 and to play volleyball once again.

Beyond anyone's control, due to two missed spring semesters due to her brain injury, essentially one full year of school, because of Doctor required withdrawal and no school allowed until fall of 2014, Ariana became effectively a junior student in the 2014-15 school years with a graduation year of 2016.

Our daughter is 6'4" with aspirations of playing Division 1 volleyball on scholarship somewhere. She more or less hasn't played any competitive volleyball for any duration since her 8th grade year due to a medically ordered directive. She was also unable to attend 2 spring semesters of school beyond her control due to a medical doctor's directive for complete mental cognitive rest. Volleyball is her passion. With her 4.12 GPA she hopes that her exposure from volleyball could help her attain an athletic scholarship to a good academic university. She currently has an offer pending her successful completion of play for the 2015-2016 volleyball year.

Please accept this explanation for Ariana's favorable hardship ruling 8.2.4.

To whom it may concern:

My name is Ariana Wiltjer and I will be a senior next year at Jesuit High School. Unfortunately, throughout the last four years, I have not been completely healthy for any duration of time. I am applying for hardship eligibility because of what has happened to me throughout this time. Despite what many have thought, I have made it through major hip surgery and two severe concussions, and was finally released by my doctor to play volleyball. Unfortunately, before this last high school season, I was not able to play in a complete high school season. When I found out freshman year that I had problems with my hip, my season was cut short. In the spring of my freshman year, I had surgery, which took over 6 months to recover from. This recovery pushed into the next high school season of my sophomore year. Then, in December of my sophomore year, I got my first severe concussion while training at the Olympic Training Center in Colorado, keeping me out of school that entire second semester. In September of 2013, which would have been my junior year, I got my second severe concussion, leaving me out of volleyball for that season and my second spring semester of school the following semester.

Even though I am a student-athlete who takes great pride in academics and my grades, I identify myself through volleyball. Volleyball has always been my passion. Being without volleyball or my teammates for the majority of the last four years has been one of the toughest

things on me because volleyball was, and is again, a huge part of my life. I am happiest when I'm on the volleyball court.

Not only did my hip surgery and concussions take me out of the volleyball circle, but also it took me out of school for two entire semesters of school. Because I wasn't getting any better, my doctor directed me to withdraw from school so that I could make a full recovery. This left me an entire year behind my classmates of 2015, causing me to get off track to graduate on time and to reclassify to the class of 2016.

My dreams have always been to play Division 1 college volleyball and to play professionally one day. Being out of volleyball for so long, my recruiting process was set to a standstill for a long time. Luckily, in addition to my strong academics, I was able to verbally commit to play college volleyball next year. With my health history, my coaches really want to be sure I can make it through this high school and club seasons while staying healthy. Despite my personal desires to play college volleyball, it is also very important for me to use this as a method to send me to college. Without a scholarship, my family would not be able to afford to send me to college or get the type of education that I want. With my GPA of 4.12 combined with my skills in volleyball, I might be able to get a door opened to be able to go to great academic school that I might not get into otherwise if I didn't play volleyball. Volleyball separates me from the masses.

Playing volleyball at Jesuit isn't just a fun thing to do; it is like being part of a family. Even though I've missed so many seasons and haven't yet been able to play one complete season, my coaches and teammates have been nothing but supportive of me. I would love the chance to be able to represent my high school and compete for my school, especially during my senior year. Not only do I feel like I can bring something to the court, but I also think that I am

an important part to my team as a leader and as a friend. Senior year will not be the same without my sisters, Coach Zimmerlee, and my favorite sport.

Please consider giving me this opportunity by granting me my eligibility to play my senior season.

To Whom it May Concern:

The above named person is a patient at the Oregon Health & Sciences University.

She has been diagnosed with concussion and post-concussive syndrome. I expect a full recovery in 3 months.

She will require time to work with a neurologist, a neuro-ophthalmologist, and a team of therapists who specialize in concussion over that 3-month time period.

She will take amitriptyline for chronic post-concussive headache and ondansetron for intermittent nausea.

In the meantime, she should be allowed 50% more time in school to complete tasks, including tests, compared to her peers.

She may not participate in any physical activity until cleared by her physician. Nor may she attend practices or games as a spectator.
