Good morning Gabe,

Thanks for your time this morning and hopefully we can get this situation clarified and settled for you and OSAA.

When we decided that Brian would attend Summit High School, my fiancé and I were residing in the Summit district at 1749 SW Troon. We had moved into that address in January of 2015 knowing that we would be purchasing a home and most likely moving sometime in September. Our family had made the decision that Brian would attend Summit somewhere around the month of March when we had started a conversation with yourself and Coach Padilla. I had let Coach Padilla know that our plan was to move sometime in September since we were buying a house and I wasn't exactly sure what area we would be in. I knew that if Brian had started there and had gotten enrolled with our address at 1749 SW Troon and ended up moving after, we would be fine.
