



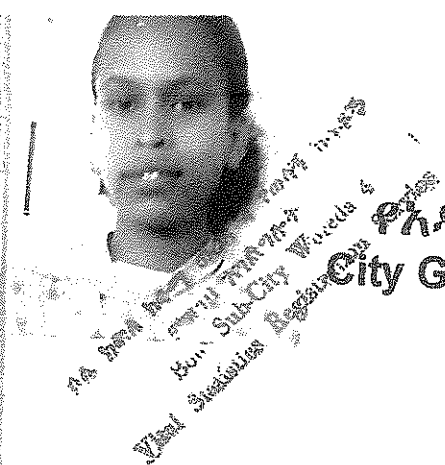

STEP 8 Appeals Process

DISTRICT COMMITTEE DECISIONS: Appeals of District Committee decisions will be heard by the OSAA Eligibility Appeals Board. If denied by the OSAA Eligibility Appeals Board, an appeal may be made to a Hearings Officer under Rule 8.11, "Hearings Officer". Appeals to the Hearings Officer shall include an appeal fee of \$200.

OSAA EXECUTIVE DIRECTOR DECISIONS: Appeals of OSAA Executive Director decisions regarding age, fifth year, grade deficiency, and non-CSIET foreign students are heard by the OSAA Executive Board. If denied by the OSAA Executive Board, an appeal may be made to a Hearings Officer under Rule 8.11, "Hearings Officer". Appeals to the Hearings Officer shall include an appeal fee of \$200.

ELIGIBILITY APPEAL FILING FEE: "Any party filing an appeal of a decision by the District Athletic Committee to the Eligibility Appeals Board or a decision of the Executive Director to the Executive Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal." We are writing to explain why our daughter, Shashu Nieuwstraten, has no transcripts or school records. We adopted her from Ethiopia in January, 2014. She went to a village primary school in the small village where she lived in Tigray, in northern Ethiopia. When she was thirteen, she was orphaned and placed in an orphanage. Sadly, she was not provided an education while she was in the orphanage for a year and a half.

When she came to America, her English was very limited. She was also grieving the loss of her family, her culture and all that was familiar to her. Since I (Bonnie) have a degree in Education and had taught for twelve years, I felt that it was best to begin to educate her at home, while she adjusted to the culture and learned the language. She has made fairly good progress in the short time she's been here, and she is excited to go to an American high school.

Last fall she played on a recreational soccer team in our community. She loved playing and getting to know some girls. She has been practicing hard with the soccer team at Wilsonville High School, and has participated in all the optional practices and conditioning that were offered this summer. She has been getting to know some of the girls that she'll be going to school with and it has

increased her confidence to be able to interact positively with her peers without any academic pressure.

We are hoping that the committee that is reviewing this case will take very carefully under consideration the unique circumstances that have brought Shashu to Wilsonville High School without any previous formal education or academic records. She is very excited to play soccer and be part of a team. We feel that being a part of this soccer team will play a pivotal role in her transition to high school and are very hopeful that you will approve her eligibility to play soccer this fall.
