This letter is to inform you that I have treated Gabriel Schultz for Major Depressive Disorder with secondary anxiety since his began treatment in my clinical psychology practice on April 24, 2015.

Gabriel has successfully responded to psychotherapy and no longer suffers from major depressive disorder symptoms.

He was unable to complete his spring term of 9th grade due to untreated symptoms of severe depression and anxiety. Successful treatment has allowed Gabriel to return to playing high school football.

I recommend that Gabriel receive a hardship waiver that allows him to qualify for the 2015 high school football season at Tigard High School.

I believe it would be very harmful to Gabriel's mental health to be forbidden from playing high school football this year

I'm writing this letter to you to support and explain the circumstances behind my son's, Gabriel Schultz, request for a hardship waiver. Gabriel attended Tualatin High School through the approval of an out-of-district transfer for the 2014-2015 school year. Gabriel grew up in the Tigard school system and continues to live within the Tigard school boundaries but we have family members who attended Tualatin High School and it was decided that Gabriel would follow in that tradition. In the winter of 2015, Gabriel started showing signs and symptoms that he was not well and I became deeply concerned. Gabriel's counselor at Tualatin High School was notified of my concerns and many of Gabriel's teachers were working to provide assistance to help Gabriel continue his education. As we moved toward the spring semester in school, it became very clear that Gabriel required urgent medical treatment. It was then that we received an official medical diagnosis that Gabriel had been suffering from Major Depressive Disorder with secondary anxiety. Despite everyone's best efforts involved, Gabriel became incapacitated and could no longer attend high school classes or focus on his education in any alternative way. We were forced to withdraw Gabriel entirely from school in April of 2015 so he could focus on obtaining the needed medical treatment that was prescribed for him. Education is highly regarded in our home so this was not a desired outcome but my son's health had to take priority above all else. Gabriel has always been involved in athletics since he was a young boy. In the past, football and basketball have been a source of happiness and innocence for him. Gabriel's physicians felt that it was best to keep him participating in all sports and/or activities if Gabriel showed any interest in them. We have supported this process and although it did not happen overnight, we have seen the return of Gabriel's desire to participate in things outside the home with effective medical treatment. Gabriel has decided to transfer back to his neighborhood high school (Tigard) after revealing during the course of his therapy that he severely missed his friends and former familiar social circles. I supported this decision at the advice of his physicians because it was decided that would be the best environment for Gabriel to thrive in. Gabriel has shown great improvement with medical treatment and at this time no longer suffers from major depressive disorder symptoms. It is very important to Gabriel to resume playing football as well as return to classes at the start of the school year at Tigard High School. It means everything to me to see my son once again care about his education and participating in these programs that bring joy to him. I respectfully request support from the OSAA to grant my son this hardship waiver based on his individual circumstances and the supporting medical documentation from his physicians that I have enclosed. I have also enclosed supporting documentation from his previous school counselor at Tualatin High School. Everyone involved wants to see Gabriel continue on the course of wellness and I truly believe taking sports away from him could be harmful to his mental well-being. Thank you for your time and consideration in this request.

Dear OSAA:

My name is Gabriel Schultz and I am a transfer student to Tigard High School from Tualatin High School. I would like to request an exception to your eligibility rules that would allow me to play football this year due to hardship.

I understand that, traditionally, students are ineligible from participating in sports who do not maintain satisfactory attendance and passing grades in their academic courses. I also understand that this is intended to put less emphasis on sports and more on academics within the education system. However, my medical condition made it impossible for me to continue attending school in the spring of 2015 and I had to withdraw from all my courses.

I have received effective medical treatment for my condition and feel that I can return to high school at this time for the 2015-2016 academic year. I will work very hard to get back on track in my courses and maintain passing grades. I also feel that I am ready to participate in sports again and playing football is very important to me.

While I understand and support the rules and restrictions put into place by the OSAA, I respectfully request that an exception be made due to the circumstances.



To Whom It May Concern:

Last year I was Gabriel Schultz's school counselor. I have known him for the past year. At the beginning of second semester Gabriel was struggling with school. In April he was diagnosed with major depressive disorder. We tried to shorten his schedule to see if that would help him, but unfortunately that didn't work. In May we received a 504 medical statement from Dr. Gary Monkarsh and in that he stated that Gabriel was unable to attend school due to incapacitating depression with secondary anxiety. We (Gabriel's mom, Dr. Monkarsh, and myself) talked about tutoring, but at that point it wasn't something he could handle. We started the 504 process in late April/May, but since he wasn't able to continue school we weren't able to finish the 504 process and planned on wrapping it up at the beginning of this school year (2015-2016). He is now attending Tigard High School and his new counselor will continue with the 504 eligibility.

Football is extremely important to Gabriel and we are asking that you please consider him for hardship eligibility.
