To whom it may concern,

I'd like to write a letter of support on behalf of Luke Johnson to be able to be eligible to participate in Sunset athletics. Luke suffered from a moderate brain injury that had him hospitalized last February.

1. Luke did not complete five classes last spring. At the advise of Luke's care provider and as is also a common practice for many of our student with head injuries, I reduced Luke's schedule spring semester. This accommodation was in place to not over tax his brain and to allow it to heal.

2. I also did not recommend Luke take summer school classes because Sunset HS and the Beaverton School District did not offer any classes that would count towards his graduation. The thought was also to give Luke's brain time to hopefully heal so that Luke might be able to return to athletics this fall. The other consideration is that students and their families pay for summer school out of their pocket and it did not make sense for Luke to pay for a credit recovery class that did not count towards his graduation requirements.

3. I met with Luke and his parents last spring and we put together a graduation plan. Luke is on track to graduate with his class June 2016 if he passes all the classes his is scheduled to take this year. He has a full load of classes both semesters.

Thanks Peter, appreciate the swift reply. Here is the information requested :

February 22nd 2015

Luke fell from a skateboard.

He was admitted into Trauma ward via A&E @ Randall Children's Acute Care, Portland. He suffered :-

- SAH (subarachnoid hemorrhage)
- Temporal skull fracture

February 24th 2015

Luke is discharged from hospital by neurosurgeon Dr. Adler.

- Speech Pathologist confirms direction for home care and follow up appointments.
- Total physical and cognitive rest in a quiet room with very gradual return to mental activity..
- His is told no return to soccer of 4 months.

March / April 2015

Luke's ability to attend class more than once a day is not possible / Hope Pearson reiterates Sunset's support and authorizes his schedule.

- Continued intense headaches – neurosurgeon tries different medications.
- Commences program to treat vertigo at Legacy Emmanuel Hospital.
- Luke visits Legacy Emmanuel Neuro Trauma Clinic for evaluations by Dr.Monica Wehby
- Neurosurgeon confirm difficulty for the recovery to be successful in a noisy / cluttered environment.

May / June 2015

Luke is still part-time at school, Sunset recognize his continued struggles due to

very slow return to cognitive ability.

- He is able to develop to two classes a day / with Hope Pearson's direct supervision.
- Finishes semester still on a very reduced schedule.

July 24th 2015

Luke is assessed through detailed evaluation from Dr. Monica Wehby / Emmanuel Legacy Acute Care

- He is cleared to return to physical activity 100% / including soccer – immediately.
- He is cleared to return to studying full time on the commencement of the fall semester.
