Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I write this letter on behalf of Maleah Maier. Maleah is a great kid who suffers from major depression. She receives professional help and has a strong support system in place. However, she still struggles day to day and ultimately tried to commit suicide after soccer season last fall.

Maleah was enrolled at Putnam last fall and has competed in soccer for us the last two seasons. After her attempt at suicide last fall she attended the Perry Center then Clackamas Web Academy so she could be monitored. She does not live in our area but is enrolled back here through open enrollment therefore she is considered an illegal transfer even though she's competed for us the past two seasons.

Due to being hospitalized several times and bouncing from program to program Meleah is also lacking credits resulting in her not passing 5 classes last semester and she does not meet the criteria for satisfactory progress towards graduation.

Although Maleah is ineligible on several levels she comes to mind as the poster child for why we have the appeal process. She struggles with major depression and soccer is an outlet and source of happiness for her. It gives her something to look forward to, a time to interact with other positive kids, so I hope that this appeal is granted for her physical and mental health.

Maleah has always competed for Rex Putnam so there is no previous school principal to get a letter from. Clackamas Web Academy is a charter school in our district that doesn't offer sports so their students that reside in our district compete for us.

Credit Recovery Plan

Maleah does not have a plan to graduate on time at this point. Treatment for her mental illness is the priority at this point. However, she is taking a full load of classes at Putnam this semester and if her depression is controlled she has the skills to pass all her classes and she will enroll in summer school next summer. If she does this then she will be in a situation where she can graduate on time.
