Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I am writing this letter in support of Fidel Morales being granted eligibility for the 2015-16 school year. Fidel's situation is one in which he has not had a choice in his moving to Portland and back.

Last soccer season, Fidel played soccer for Dayton. His parents were divorced in the winter and he and his dad no longer had a place to live in Dayton. Homeless, they were able to live with his dad's sister in Portland. Over the summer he had to seek a home elsewhere. Fortunately for them, they were able to move in with his other sister in McMinnville. He has been approved as our student under Title X.

It makes the most sense that he chose to attend Dayton again being as he is familiar with our school, staff, our procedures and expectations. However, because he has been affiliated with Dayton in the last calendar year, he can only be granted eligibility through the hardship process.

Fidel is a good kid that has been through some unfortunate circumstances. Having soccer back in his life and a "home" in Dayton High School will help him find some normalcy in his life.

I am fully in support of Fidel Morales being granted eligibility for soccer this season.
