



Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

In 2008, a new job opportunity moved our family from Scappoose to Alaska and Jacob never adjusted to living in Alaska. Prior to his junior year in high school he asked to return to Scappoose for high school so we promised him we would consider it for his senior year. Jacob has close family in Scappoose who have agreed to have him live with them.

While in the Anchorage School District and a private Catholic High School in Alaska, Jacob's grades drastically changed from the honor roll in middle school to just passing in high school. Jacob is a smart boy who excelled in a trade school opportunity last year and received a certificate in basic computer operations which qualifies him for jobs at the Best Buy types, but he is too young to meet their employment requirements.




Cowapa Hardship Committee,


