I am writing this letter to ask for consideration for special circumstances for the chance to be able to play football as a 5th year Senior. I have only played football for 3 years in High School so therefore I have 1 year of eligibility left.

The counselor at Central High School in my opinion was inaccurate concerning my attendance as I attended regularly with only 15 days missed because of illness and the home where I was living burned down. I attended regular classes and I even enrolled in summer school to make sure that I am in line to graduate from Central Medford High School. I can make 10 credits at Central per year and I only need 9.25 which I know is doable.

When I was attending school in Washington for my Junior year my attendance was poor because I needed to be home to take care of my younger brother because my parents were both doing drugs (methamphetamines) so I needed to be there to protect him. Therefore my attendance was very poor. My Father abandoned the family in March of my Junior year so I basically dropped out of school. In June my Mother abandoned me and left me alone. I called my Grandparents and they sent me a train ticket to come to Medford after working the DHS in Washington.

When I arrived in Medford from Washington I had a lot of issues from my abandonment which led to me having poor attendance and bad grades. My Grandparents tried to help but I had a very hard time coping. I had become depressed and worried about my brother every day. When my grades became so bad my counselor and the Assistant Principal suggested that I go to Central High School where I would receive more one on one help. I believe that was the best thing I have ever done for myself. When I left North Medford I only had .25 earned credits, after attending Central High School I earned 4 credits. I am certain that I will sore on returning to school. My Grandparents are very supportive and I owe a lot to them for their love and their support I don't know where I would be without them in my life and the rest of my family as well.

I would very much like to play football this year for North Medford High School for my Senior Year as it is also my plan to return after my credits are earned to be able to walk in graduation as this is a gift I will have earned for myself. My plan for my future goal is to go on to a University here in Oregon.
