Parent concerns: Kim is concerned with Dylan's abilities and math skills. She wants to be sure what he struggles in gets supported with Special Education support.

Academic Performance:

Math: On the Woodcock Johnson academic achievement subtests, Dylan's math scores are as follows:

Calculation- 72
Math Fluency- 73
Applied Problems- 73
Quantitative Concepts- 63
Broad Math Score, 66

His fluency scores were 97% accurate, but considered low due to the amount he did in 3 minutes (58 total). He demonstrated knowledge of multiplying and dividing basic facts, and multiplying 2 digits by one digit accurately. He subtract double digits by double digits correctly 50% of the time because no matter the number's position, he would subtract from the big one. In his core Math class, he scores 'F's on his homework assignments and his class tests, but attempted 83% of his assignments. Dylan will benefit from specially designed instruction in math to increase missing remedial skills, like the rules in subtracting, as well as explicit instruction in grade level concepts.

Writing: On the WJ-III Dylan's writing scores are as follows:

Writing Fluency- 77
Writing Samples- 86
Spelling- 89
Broad Written Score, 70

Dylan exhibits knowledge of how to write complete sentences, but requires extended time to start and then complete grade level writing assignments. He will benefit from specially designed instruction in writing that supports both mechanics and fluency.

Reading: On the WJ-III Dylan's reading scores are as follows:

Basic Rdg Skills- 85
Rdg Comp Skills- 81
Letter-Word identification-84
Rdg fluency- 82
Passage Comp- 77
Rdg Vocabulary- 89

Dylan's reading scores are low to low average. The team would like to see him receive support in reading fluency to build his phonemic awareness, and in reading comprehension to increase his level of understanding passages that he reads.

Dear Mr. Welter,

I love my great grandson with my whole heart my soul, If I could take back what he was been through in his short life, I would in a heartbeat.

In his eighth grade year, the man Dylan had thought was his father, left Dylan and his mother. It was at this time that Dylan discovered the man was not actually his father. This was a huge hurt and blow to Dylan. A few months later, his own mother abandoned him when her life was taken over with drugs. He was devastated and cried for months. His mother was everything to him. He went through many changes during this time.

He started living with his grandmother and attending Cleveland High School but he was struggling. In April, 2014, Dylan's mother was arrested and was sent to prison. That is the same day Dylan's life came crashing down. He was arrested for fighting a kid and beating him up and sent to JDH. My husband and I visited Dylan every day of the week. We worked with his attorney, his probation officer and then when he was released two months later in June, he came to live with us.

He was expelled from PPS due to his behavior for hurting another person. But even though he was out of JDH, he was not put into an alternative school until November 2014. With all the time off for the holidays, he really didn't get any real schooling until January 2015. That is why he didn't receive the credits necessary when we enrolled him at Franklin.


Dylan has always found an outlet in football. He thrived in CYO football from 6th to 8th grade. At Cleveland he played on Varsity as a Freshman. He was first string running back and received a letter in football and wrestling. His desire is to play football. When he finally got to join the Franklin football team in August, he was so happy. Dear Mr. Welter:

I am writing this letter in support of a hardship request/exemption for my client, Dylan Brown. I represent Dylan as court appointed counsel in a long term child welfare proceeding. Dylan is a dependent ward in long term foster care with his great grandmother. Dylan is 16 years old. He is a sweet kid, with a ready smile. He is an incredible footballer and made varsity as a freshman. There is a belief amongst his family, former coaches and teachers, juvenile court and child welfare, that football may be the one thing that propels him through high school, into college and beyond. He has weathered and survived much in his few years: single parent, exposure to domestic violence and parental substance abuse, parental abandonment. He loves his mom, but she is inconsistent and disappears which causes much heart ache. Dylan is also a crossover kid who has made a significant mistake and who works every single day to correct that mistake. As a freshman, just after turning 15, he got himself into legal trouble with a measure 11 felony charge. He found himself detained and facing prosecution through late spring, 2014. Through that process, and coming out the other side, Dylan took responsibility, admitted his guilt and was permitted by the prosecutor and court to be placed on probation, rather than face a corrections outcome.

He meets regularly with his probation officer and is working hard to successfully complete his court ordered probation requirements. Another significant penalty he experienced as a result of his charge was expulsion from school and the inability to play football last year. He attended an alternative education program at Helensview High School, remained in foster care with his great grandmother and made a plan to return to high school, get his diploma and play football again. This year, he has re-enrolled at Franklin and gone out for football. We recently learned he was credit deficient. From the school records, he appears to have 8.5 credits with 10.5 required for junior students. I have been able to track additional credit through his school attendance while he was in detention, spring, 2014, where he earned .827 credit. This leaves him 1.17 credits short. Dylan experienced a delay entering school last fall, while on a waiting list for Helensview, and likely lost some opportunity for credit acquisition in the first 5-6 weeks of the school year, at no fault of his own. Dylan is also a young man with learning disabilities in reading, writing and math; eligible for special education services through an individual education plan (IEP). Academics are difficult for him and he perseveres. He wants a regular high school diploma and continues to work toward this. His IEP team is considering if he should seek a modified diploma which would allow him to have 24 credits and shorten the deficit to .673 for eligibility.

I have spent 22 years as a children's public defender, working day in and day out to help my clients—my "kids" maneuver through the foster care system, acquire appropriate school and community supports, and transition successfully to adulthood. It is a daunting challenge. Very few youth in foster care successfully emerge in their early 20's ready to live independently. Only 1-2% go on to post-secondary education; many leave foster care, homeless, without employment and are at risk for further exploitation.

I believe Dylan will be an exception. He is a survivor. He's made mistakes. Life has not been kind or fair, but he pushes forward. He has the love of his great grandparents and strong support from his "team", including his child welfare case manager, his mentor, and myself. There are many adults in his life who support his success and will help guide him forward. This includes his coaches, teachers and school administrators. I suspect you'll receive several letters supporting this young man's request to play football. I respectfully request your consideration for a hardship exemption. In this instance and for this young man, this will make all the difference in the trajectory of his minority and transition to adulthood. This is the first time I've written a hardship request in all my years and I truly feel this is so essential to his well-being. Football is a family he hasn't had and provides him the structure, guidance and nurturance he is desperate for and which will keep him on the right path.

To Hardship Committee:

I wanted to write in advocacy of Dylan Brown's application for a hardship waiver in order for him to play football this season of 2015. I am his DHS caseworker and have been working with Dylan for over 18 months. I have watched him grow from a middle school kid to a high school student, and as someone who has experienced enough drama and Trauma to last a lifetime. Unfortunately, Dylan has had to deal with some very tough circumstances; ones in which he was ill-equipped to handle in a healthy or positive way and that has led him to needing another chance, another opportunity to prove himself and his desire to be successful in athletics, mainly football. He has since had some very tough lessons he has processed through, and wants to be able to prove himself in a healthy way, that he can be upstanding and a contributing citizen to our society.

The reason he needs to be approved is because he was expelled from school in April 2013 due to a fight but was enrolled in an alternative school immediately after and then participated in his sophomore year at an alternative program as well. In Fall of 2014, he had to go through the Reconnection Services Department through his school district in order to placed and this took almost 6 weeks to be approved. So in my opinion he was not at fault for this delay as he was ready to start school on the first day of school that year. During his sophomore year, he wasn't awarded the amount of credits he was expected to earn. These issues are currently being figured out with the alternative program since they have a different reporting system and it seems he wasn't given the proper instruction, even though he had regular attendance and participation. Even so, he was short 1.5 credits, which he should have earned throughout the past two years, because he did not receiving any failing grades.

He is determined to stay in school, and this opportunity will be his conduit to doing so. There are so many distractions nowadays, and it is very easy for our youth to be pulled into directions of illicit activity, especially if they do not have a mother or father figure in the home, and they are trying to figure out how to survive life the best he knows how. He does have support of his great-grandparents but he needs some influence that he can relate to now, and that means him playing football and having a chance to gravitate towards his teammates who are more focused and committed to doing well and progressing in their academics then the past peers he has gravitated to before.

I thank you for your time and consideration, and I want you to know that it will be up to Dylan to make this work for him (as he did his Freshman year when he was able to play) but if he isn't given the chance to make things right, right now, then he most likely will not be confident to do so in another outlet.

Dear Mr. Welter,

I am writing to as a family friend and advocate of Dylan Brown. We have been informed that Dylan is not eligible to play in football contests due to the fact that he is a 1.5 credits shy of being on track to graduate.

I sincerely request that you consider granting him an exception.

Dylan Brown has experienced many difficulties in his young life. He lived at home with his mother until his eighth grade year when his mother's drug addiction took over her life and she basically left, leaving Dylan alone and unattended. His mother would eventually be arrested and has spent the last couple years in and out of jail. Dylan's grandmother finally realized, after a few weeks that Dylan had been abandoned and became Dylan's guardian. However, this was a turning point in Dylan's life. His attitude, his grades, his choices all began to reflect his hurt and anger of being abandoned by his mother. Her off and on again appearances into his life only brought more turmoil. Dylan will tell you himself, "I just didn't care about anything anymore". This attitude showed up in the classroom and in his personal life. His life hit rock bottom on April 9th, 2014 when he was arrested for beating a teenager up at a fast food restaurant a block from his high school. He was expelled from PPS for one year and spent the next two months in JDH. At his trial, several of his old CYO coaches testified about Dylan's character and how this violent action of his was not characteristic of Dylan. The Judge ruled that he did not have to serve jail time and was released the beginning of June into the care of his Great Grandmother. Dylan and I spoke in length about how he had been given a second chance. He had been heading down a dark path and now all he wanted was to get back to school and football and "start fresh". However, Reconnection Services did not place Dylan into an alternative school until Nov 25th, 2014. He desperately wanted to go to school but was told there were no openings for him in summer school or an alternative school. It took Reconnections Services almost 6 months (beginning of June 2014 till end of Nov 2014) before they finally placed Dylan at Helensview School. This extended absence was not of his choosing and definitely set him back academically even further than he already was. He did well at Helensview, but couldn't wait to get back to a PPS school and back to football. We were able to get him registered for Franklin High School in June 2015. He couldn't wait for school and football season to start. He began practicing with the team in July and was eagerly anticipating playing in the Jamboree last week. Hours before the game, he was told he wouldn't be able to play any contests as they just

discovered that he was shy 1.5 credits of OSAA regulations. He was devastated, to say the least.

I have watched Dylan grow up as my son and he went to the same elementary and middle school together and also played CYO football together. They ended up at different high schools as my son enrolled at Central Catholic and Dylan enrolled at Cleveland . Dylan has always been a quiet and sweet kid. He was reserved but once you got to know him realized that he loved to tease and smile. He struggled in school and was eventually diagnosed with a learning disorder and had been making strides once he received the help he needed. He is an amazing and naturally talented athlete. He was one became of those quiet leaders on the field; one the other kids looked to and respected. As a Freshman, he was quickly put on the Varsity Football team. He also lettered in Wrestling (though he doesn't really like that sport). It has been so heartbreakng to watch a kid like him hurt and bewildered and floundering in life. It took him hitting bottom before he realized he needed to get healthy on the inside. He is currently on the path of rebuilding .

Football is the one "bright spot" in his life. He struggles with feelings of being "unloved" and "stupid" and "all alone" but football is the one area in his life where he feels confident and good about himself and ahead of the game instead of always behind. Playing football is the main motivation for him at this point in his life. It is the thing that makes him happy and the thing that he looks forward to. At least at this tenuous point in Dylan's life, football is the anchor that keeps him tied to school, discipline, team mates and being around strong, admirable male figures like his coaches. It is also the only thing (in his mind) that causes him to have hope for his future. I feel like he will be a better student and young man if allowed to play football. Please grant him the ability to feel some measure of success and confidence and hop in his life as he rebuilds.
