Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I am writing this letter as consideration for Christian Crawford's eligibility to participate in sports at Westside Christian High School.

Christian Crawford attended St. Stephens Academy in Beaverton during the entire 2014-2015 school year. During that time, he resided with his mother at 1030 SW 170th Avenue, Unit 101, Beaverton, OR 97003. He participated in cross country during the entire 2014-2015 season. He then decided to participate in track with St. Stephens and in March of 2015, he began living with his track coach, Joe Storm at 11233 NW Plainview Road, Portland, OR 97223.

During the summer of 2015, he began practicing with the St. Stephens cross country team and continued to reside with Joe Storm. On July 18, 2015, the principal at St. Stephens Academy informed me that Christian could no longer practice with the cross country team at St. Stephens since he was not formally enrolled for the 2015-16 school year.

Shortly thereafter, Christian and I decided that he would attend Westside Christian High School and he began informally practicing with Coach Scott Ball.

Without my knowledge or consent, in late August Christian began practicing again with the St. Stephens Academy team. On August 4, 2015, we made the final decision that Christian would attend Westside Christian High School and he was formally enrolled that date. However, Christian continues to reside with the Coach Storm.

I reside at 17168 SW Pacific Highway, Unit 172, Tigard OR 97224. I do not know how long Christian will continue to live with the Storm family. There is nothing preventing Christian from living with me.
