

Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

The purpose of this letter is to request a Satisfactory Progress Waiver for Jesse Abel. Jesse is a junior this year. He is also a student at our local boys home, J Bar J Ranch, thus a ward of the court. Although he completed several courses over the summer, he is not making Satisfactory Progress toward graduation by .25 credit (has 10.75 credits, but should have at least 11). According to his case manager, Jesse has worked hard to catch up and will be enrolled in a full load of core classes as well as a credit recovery course to get back on track.

Jesse has finally had enough success at The Ranch to be allowed to attend public school. This is an achievement on its own. I believe this caused him to begin to get serious and start turning things around. Our plan would also include weekly grade checks for Jesse through at least the first semester.

Jesse would like to participate on the football team this Fall. I sincerely believe participation in athletics will be another significant motivator in his life and assist him in being a turnaround student who will be staying on top of his academics from here on out.
