OSAA Hardship Appeals Committee:

Silverton High School is requesting an eligibility waiver for Nathaniel Iness. Nathaniel is a junior who is currently ineligible under the "Satisfactory Progress towards Graduation" requirement. He currently has 9.50 credits entering the junior year in school and is 1.0 credit short of meeting the 10.50 credits required.

Nathaniel moved to Silverton from Copper Canyon High School in Phoenix, Arizona. During his time at Copper Canyon, Nathaniel was found eligible for a learning disability in written expression. Previous to this high school, Nathaniel was enrolled in a private school that did not offer special education services or opportunities for identification. In addition to Nathaniel's recent identification for his learning disability, he also experienced family challenges at home. During Nathaniel's first semester of his sophomore year, his father had a heart attack. It was difficult for him to focus and keep his mind on track. That semester, Nathaniel only passed four classes.

Nathaniel is currently enrolled in and passing 7 classes and is currently on track to "catch back up" with his graduation requirements at semester. He is receiving special education services based on his IEP and is meeting all of the requirements in that IEP. His previous high school administrator is supportive of this hardship request as written in his letter of support.

Based on his situation, interviews, current grades, current IEP, and credits posted to his transcript, we feel Nathaniel is deserving of an eligibility waiver to participate in fall sports.


To Whom It May Concern,

To whom it may concern:

Nathaniel Iness came to Copper Canyon in the winter transferring from a private school. We were in the process of doing a student study to see if he qualified for an IEP or a 504 plan in order to provide him with more support after his parents had inquired about the possibilities as the private school did not provide such support.

In our district/state, academic eligibility is measured differently and he would have been academically eligible if passing all current classes.

We were also going to a hardship hearing based on the fact that there was no domicile change going from the private school to our school which was due to a financial hardship incurred when the father had a heart attack. I am confident that we would have won the hardship and Nate would be playing for us had he not moved to Oregon.
