I called his mother today to ask about his credits. Yes, he has only that many credits. They were in Beulah, North Dakota for a few months and then moved to Wapitan, North Dakota for about 6 weeks due to his father's work. During those 6 weeks, he was home schooled. From there, they moved to Minnesota where he attended St. Louis Park HS from winter to early spring. He left there and came back to Oregon again due to following his father and where the work was. From that spring time until he enrolled at Estacada, he was home schooled.

Therefore, he did not earn a lot of credits due to job timing (mom would pull him out when she and her husband were told of work moving to the next job) and just being in and out of school.

Please let me know if you need more info. He has been in class every day here and is doing well academically.
