



Affirmation Statement



Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

Re: REQUEST FOR HARDSHIP EXEMPTION FOR WILLAMINA HIGH SCHOOL, MICHAEL DUNCAN

Dear Board Members:

First, please let me introduce myself. I was appointed by Yamhill County Circuit Judge John L. Collins in February, 2009, to be an advocate for Michael Duncan through the Court Appointed Child Advocacy Program (CASA). I am strictly a volunteer who cares about kids.

Previously in that same month, February 2009, the State of Oregon took custody of Michael Duncan and his siblings due to founded neglect and abuse of the children. The parents were heavily involved in the use of illegal drugs (methamphetamine). Since then Michael has been in seven placements, the latest of which was over three years ago when he was placed with Cliff and Beth Bennett in the Willamina School District. At the time of the placement, Michael started school in the Willamina Elementary School. However, due to his sporadic attendance prior to being placed into custody coupled with the many moves in foster care, Michael was very far behind scholastically. He could barely read and could not even do simple math. Quite frankly, it did not seem the Willamina School District had the staff and ability to start over at first grade with this high-needs boy. The bio-children of the Bennetts were attending the Sheridan Baptist Christian School. Michael expressed a desire to attend that school where he would work at his own pace and could hopefully get caught up to grade level. His parents, DHS and I supported the transition at that time.

So, here we are three years later. Michael has worked very hard and is nearly at grade level in all subjects. He has wanted all these years to be involved in organized school sports, but his foster family did not have the ability, or quite frankly the desire, to see that happen. However, as fall was approaching Michael's "team," a group comprised of DHS staff, myself, Michael's attorney, and several others who have been working with him, encouraged the foster parents and Michael to go out for football in Willamina. None of us understood the OSAA rule about students who transferred being ineligible for a period.

So now Michael has expressed a desire to return to public school, mainly in order that he can play sports. There are no sports offered at the private school. I strongly advocate that is in his best interest. Agreeing with Michael and me is his caseworker at DHS and other staff there. Consequently, DHS, as his legal guardian, made the decision that he would transfer to Willamina High School. Unfortunately, it was about three weeks after the school year began that the requirement came down from DHS and so, apparently, the transfer is being looked at as a mid-year transfer for OSAA rules.

Michael loves sports and I believe it could be the saving grace for this child to be able to play in football games and basketball as the year progresses. He needs the experience of being on a team, of all the things that go with being a member of a team. I understand the coach there is a very excellent coach

who emphasizes team work, good camaraderie, and family involvement. Michael is so ready for that kind of discipline and interaction at this time. I hope and trust you will find good cause to grant a hardship and allow this kid, who has been through so many disappointments in his short life, to play ball even though he has transferred from a non-OSAA member school to a school in which district he has been living for the past three years. I believe his circumstances are not the ones which were being considered when this OSAA transfer rule was put in place. Having had children and grandchildren in sports over many years, I have seen good cause for such a rule. This case is very different in my opinion.

Thank you so much for the good work you do, and thank you for considering the best interest of this child.
