Appeals Process

Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I've been told that I am required to write a letter about the circumstances which have brought me to Sandy High School, in order to be eligible for competition in cross-country. In an effort to speak with brevity, I am in Oregon living with a family who agreed to take me in after I left a treatment center. I am in Sandy now, because it is a more stable emotional environment, for me, than Florida was when I was living with my family.

I have known the family I am living with since I was young and they are helping me get back on my feet now that I have left treatment. One aspect of maintaining balance in all areas of life is staying active. This doesn't just mean cross-country, it also applies to schoolwork and social interactions. I am grateful for the opportunity that I've been given to run cross-country at Sandy High School and believe that it is an important and useful thing for me in maintaining sobriety and healthful living.
