Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.



To MVL Hardship Committee,

Lost River is requesting the MVL Hardship Committee approve the mid-year transfer of student Janelle Slightam to be eligible to complete in athletics during the 2015-16 school year for Lost River Jr/Sr High School.

Janelle's parents are divorced and her main custodian has been her father. She has spent little, if any time, with her biological mother. Janelle enrolled in September 2014 before the start of the 2014-15 school year and attended Lost River for the entire year. She participated in basketball and track and was an excellent student related to grades and behavior. She was a member of the JV basketball program last year and a member of the varsity relay team which won 1st in state. She is not a standout athlete, but she did contribute to her track team.

Due to some issues outside of school, her father sent her to live with her mother in California and attend San Lorenzo Unified High School. She enrolled for the 2015-16 school year and attended approximately 2-weeks of classes at San Lorenzo. When it became clear that living with her mother was not the best place for Janelle, she returned to live with her father and enrolled in Lost River on September 21, 2015, our 19th day of class at Lost River.

Being at Lost River is the best placement for her as a student and a young lady. She has earned a 3.86 gpa at Lost River and has not had any behavior infractions above being tardy to class. She is outgoing and is a very positive student.

This hardship is not based on what Janelle might add to our athletic department, but what is best for a young lady academically and emotionally. Should Janelle be granted or not granted this hardship, she will remain at Lost River, but as AD's and/or coaches, we all know the impact athletics have on our students and Janelle should have the opportunity to have athletics remain a part of her high school experience.
