SWC Hardship Committee,

Raphael Hernandez is a homeless student attending North Medford High School. He transferred back to North Medford on September 8, 2015. He previously attended North Medford High School for the first three quarters of his freshmen year, before transferring to Phoenix HS for the fourth quarter. He is ineligible for multiple reasons:

- Transfer without change of Joint Residence
- Academically ineligible. Earned 2.25 credits previous two quarters, needed to earn 2.5 credits
- Prior affiliation, he has had contact with our kids and coaches within the last year, BECAUSE HE ATTENDED North Medford HS

Except for the fourth quarter last year, when Raphael was moving between his mom's home, a homeless shelter, and his brothers' home, Raphael had maintained good enough grades to be eligible. The hardship he has endured having to move three times in a short period of time led to a lack of stability meeting his most basic needs, making school secondary. We believe that with a stable place to live, and keeping him connected to school with a positive outlet, allowing him to participate in sports will be a great benefit to him.

Given the hardships beyond his control, we believe Raphael should be granted the opportunity to participate in OSAA activities. He is interested in making connections and having a healthy outlet, as well as motivations to do well in the classroom.
