It wasn't easy to leave my friends at Willamette High School but after being embarrassed by the school staff, having a coach unwilling to work with the parents and Athletic Director, and not feeling like our sport is important to the school, I knew it was time to find a new program.

One of my worst moments as a cheerleader at Willamette High School was when my teacher stood in the front of the room and said how she dislikes cheerleaders and that real athletes don't wear big bows in their hair. My teacher knew that there were several cheerleaders in her class, but she didn't seem to care. The school forced her to apologize for this, but her apology will never take away how I felt that day. Things continued to get more and more difficult until finally we were moved out of Cascade due to an outside recreation league. We were brought back to the high school to the upstairs gym, but practice times were very limited.

I feel that after 2 years of being on the Willamette cheer team the problems had never been fixed, which ended up with me leaving my friends and my teammates for a new start. I am currently part of the varsity Churchill Cheer team, and couldn't be more excited for this season. I feel this was the best decision for me, I couldn't be happier. I have the most amazing coach, teammates and school. I ask that you please reconsider my eligibility for the competition Cheer season, all I want is to be able to compete with my new team.
