I Candace Gingerich mother of Dylan Avery Shay am writing today as a plea for Dylan in regards to his hardship case that has been filed.

Dylan's father and I divorced when he was 4 and I moved to Oregon from Arizona to start a new life. Dylan and I and his 2 brothers all moved to Vernonia in 2005 and they began school here. Their father then filed for sole custody and as I hired a lawyer and tried to fight he was given sole custody for one and a half years. This as you can imagine had a detrimental affect on all 3 boys. Not one of them wanted to be uprooted and taken away from their mother. However I had to do what the court ordered and I complied. And in the meantime I filed an appeal. I finally got the boys back and it was a hard road but with lots of hard work and patience got them back on track.

However, 5 years ago their after getting them back, their father started a downward spiral and ended up being sentenced to 10 years in prison. He was jailed 2 years ago but began serving his prison sentence this year. This had a huge impact on Dylan. His grades began suffering his interests in sports did too. This summer he and I began butting heads, he turned to a family friend for solice. This family friend Mike Pihl has been an absolute Godsend. Dylan now resides with him and is Thriving! I would like to ask that you please take Dylan's history and the fact that he has shown great improvement this year into consideration when deciding if Dylan will be allowed to participate in the sports activities and competitions as well as graduating with his class.

shall be extended to include the time of Defendant's temporary release, pursuant to A.R.S. §13-901(B).

IT IS FURTHER ORDERED that the Defendant must submit to DNA testing for law enforcement identification purposes in accordance with A.R.S. §13-610.

IT IS FURTHER ORDERED granting the Motion to Dismiss the following: Counts 1 and 3 - 12; M.C.A.O. agrees not to file charges arising from Phoenix Police Departmental Report 2013-01754354.

IT IS FURTHER ORDERED authorizing the Sheriff of Maricopa County to deliver the Defendant to the Arizona Department of Corrections to carry out the term of imprisonment set forth herein.

IT IS FURTHER ORDERED the Clerk of the Superior Court remit to the Arizona Department of Corrections a copy of this Order or the Order of Confinement together with all presentence reports, probation violation reports, and medical and psychological reports that are not sealed in this cause relating to the Defendant.

The presentence investigation report is filed under this cause.

IT IS FURTHER ORDERED the Defendant forfeit all interest in the currency, weapons, ammunition and any weapon accessories seized in Glendale Police Departmental Report No. 13-108609.
