If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

Trevors dad has called me several times stating that Trevor had not been home for several days at a time. Then the school called stating that Trevor was suspended for 5 days. I am writing this letter on behalf of Trevor Jones in his quest to compete in athletics for La Pine High School during the 2015-2016 school year. Trevor enrolled in our high school less than two weeks ago and came to me stating he was interested in wrestling. He attended Fred Beyer High School living with his dad before getting into trouble for being under the influence of marijuana. He was suspended from school and mother decided it was time for him to come live with her in La Pine.

I don't know a whole lot about Trevor, since he hasn't been here very long. In talking with him, he seems pretty genuine and wants to make better choices and feels that living with mom will help with that. I also told him that there is zero tolerance for athletes who possess or who are under the influence of alcohol, drugs, or tobacco at La Pine High School.

In looking at his transcripts, it looks as if he is on track to graduate but had trouble with his math classes and World Geography. He failed two classes at Fred Beyer High School, therefore passing 4 out of 6 classes last semester. He will be ineligible until the end of the trimester, which is 12/11. He is hoping to be able to wrestle after that point, given that he passes the required amount of classes.

I think sports would be good for Trevor and would help in his decision-making here at La Pine. I feel that change of demographics and being a part of a team will help him be successful.

Good Morning

I will send you Student Discipline Reports for Trevor Jones from the 2014-2015 and 2015-2016 school years. Trevor was referred to the Student Supervision office 38 times for a variety of issues during the 2014-2015 school year and was home suspended for 6 days. From August - October of the current school year, he was referred to the Student Supervision office 26 times and home suspended for 5 days.

I met with Trevor and his father early on in the school year because Trevor wasn't coming home. Trevor did not show good citizenship in class and was referred several times by teachers for his defiant and disruptive behavior. His last offense was coming late to school while under the influence of marijuana - this resulted in a 5 day home suspension. I offered Trevor the opportunity to have his suspension reduced to 3 days if he attended drug intervention classes but neither he nor his father accepted this offer.

I believe Trevor needs to be involved in sports as does attempt to keep his behavior under control in order to stay eligible. We offered him counseling on campus with our Student Assistant Specialist and referred him to many on campus intervention programs in order to help him with his defiance / disruption issues.

His attendance was okay - I'll add his attendance reports to the information I am sending to you! Hope this helps! Our Registrar can fax all this information to you if you'd like to send me a fax number. Thanks!
