

Dear Donella Boldt:

This is to inform you that for the 2015-2016 school year, Derk Boldt has been released and approved to attend Lebanon instead of Central Linn.

The Lebanon Community School District will not pay transportation costs or other excess costs.

An Inter-district Transfer Request once approved will remain valid until high school graduation.
