Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals board to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.



Due to various reasons, we wanted to try the neighborhood HS. But the Beaverton school district doesn't allow any shadowing nor even meeting with the teachers before a transfer. More so, a student is not allowed to be enrolled in two schools on the same day. So, we had to go through all the paperwork to give it a try. However, on the 1<sup>st</sup> day, after attending the neighborhood HS for just 2.5 hours, Kelvin quickly realized that it was a big mistake to leave VC. So, we immediately went to VCHS office and had canceled the withdrawal paperwork.
