Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

My Open district transfer to West Linn High School took place at the beginning of the 2014-15 school year, which meant I would begin the school year as a sophomore at West Linn. My reasoning for the transfer was to enroll myself in a better education program. My home address has never changed and I have always lived at 4337 SE weedman st Milwaukie, OR, 97222. Many things occurred that caused me to transfer back to Milwaukie High School Where I Originally began my high school career. On numerous occasions I was bullied or, told I was "ghetto" due to the fact that I lived in Milwaukie by numerous students. I tried to let it go and be a bigger person but it never changed. This drove me to feel uncomfortable going to school and caused me to fall behind and fail classes. Being at a place where I didn't feel comfortable nor welcome defeated the purpose of being in a better education program. It only drove me to not want to go to class and caused me to become depressed. The reasoning for me not transferring back to Milwaukie at the beginning of the year was, I thought maybe at the start of a new year things would be different. Things did not change and about three weeks into the 2015-16 school year I had to go to my parents about what was going on because I did not want to be in a atmosphere where I was uncomfortable and depressed. This hardship has affected me as an individual and I wanted to take myself out of that situation. I transferred back to Milwaukie because the students and staff make me feel welcome and give me the support I need to be successful. I think it is important that I feel welcome and comfortable in a place where I am required to interact with my teachers and peers on a daily basis. Recently since my transfer I have had a lot more success as a student and mentally I have been in a better state of mind and I am no longer depressed. Being depressed due to feeling uncomfortable at West Linn did not only affect me in the classroom, but it affected me as a person and my life outside of school. I am now in a great place and that has given me the motivation that i didn't have before to go to class and be successful as a student. That is very important to me because I do not plan to stop my education after High School and I needed to be somewhere I feel comfortable to get through High School.

My son Cole Roberts transferred to West Linn high school , thru open enrollment , for his Sophomore year. We made the transfer before the September 2014 school year started. The transfer was made so that Cole could have an opportunity for a college prep school education.

Cole started struggling midway through the school year. He was having a lot of anxiety and depression. Not wanting to attend school therefore he got behind in his classes.

Cole continued at West Linn, starting the 2015/2016 school year and a few weeks into the year he came to me and told me he was being bullied and had been since the previous year and wanted to transfer back to Milwaukie High School. After a lot of consideration we decided this was for the best. Cole seems to be doing very well. He is so much happier and is working very hard to achieve his goals so he can further his education beyond high school.

Our address has always been a Milwaukie address throughout the entire process.
