Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

THE SCHOOL

A private, non-denominational school founded in 1982, the Portland Waldorf School has 276 students enrolled from preschool through grade twelve. Sixty-five High School students, including 17 in the senior class, are enrolled for the 2015-16 school year.

The Portland Waldorf School is located in Milwaukie, part of the metropolitan Portland area, in Clackamas County, Oregon. The students come from a broad range of socio-economic, national, religious, and racial backgrounds.

THE PHILOSOPHY OF WALDORF EDUCATION

There are over 800 Waldorf schools world-wide and over 150 in the United States. Waldorf education is based on the educational principles of the philosopher, scientist, and educator, Rudolf Steiner (1861-1925).

The rich Waldorf curriculum and innovative teaching approach provide a unique education that addresses the young child and maturing adolescent, working to develop clarity of thought, balance in feeling, and initiative in action. It is an education born of and infused with ideals; it is an education for life.

ACCREDITATION

Portland Waldorf High School is accredited by the Association of Waldorf Schools of North America and the Northwest Accreditation Commission/AdvancEd.

THE CURRICULUM

The Portland Waldorf School offers an interdisciplinary curriculum with equal attention to academic subjects, fine arts, practical arts and crafts, extra-curricular activities, movement, and community service. Our multi-faceted program provides excellent preparation for college, but our foremost goal is to prepare our students for free and responsible lives as adults.

Students receive personalized attention in small class settings and take all subjects throughout the four years of high school. Conceptual subjects are taught in intensive three- to four-week "main lesson" blocks equal to at least 1/4 credit (30 to 40 class hours). Main lessons and other content-rich classes emphasize development of independent investigation, critical thinking, and applied academic and creative skills.

To Whom It May Concern:

I am writing on behalf of my son Bjorn Johansson, who is enrolled as a tenth grade student at the Portland Waldorf School. Bjorn attended PWS for his eighth grade and ninth grade years and then began his sophomore year at Lincoln High School. Bjorn's Mother, Vanessa, was diagnosed with cancer (sarcoma) in the early summer and recently had surgery at OHSU. We enrolled Bjorn locally as a way to ease the time constraints of commuting between Northwest Portland and Milwaukie while we dealt with her ensuing surgery and ongoing therapies.


However, we soon discovered the time savings were not a net benefit to our family as it deprived Bjorn of the community of friends, teachers and coaches to which he had become accustomed; not to mention a superior academic experience. This community and school, we discovered, are in fact essential to our family as we walk through this health crisis.

While at Lincoln Bjorn had no contact with the basketball program or any other sports program and left the school in good standing and with a GPA of 3.5. Please see the accompanying support documentation from Lincoln High School.

I appeal to you as the conference governing body to allow Bjorn to be eligible to play basketball this year as the community support he receives from his teammates and the coaches is of incalculable value to him and our family.


