Appeals of decisions made by the District Athletic Committee are heard by the OSAA Eligibility Appeals Board. Appeals must be requested in writing, or e-mail, and submitted to the OSAA Executive Director.

Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

To Whom it May Concern,

My name is Carley Judson and I am a transfer student to North Valley High School from ACE High School. I would like to request an exception to your eligibility rules that would allow me to play swim this year due to hardship.

I understand that, traditionally, transfer students are ineligible from sports for one academic year. I also understand that this is intended to put less emphasis on sports and more on academics within the education system. However, my transfer was not based on my own request, but rather on hardship within my familial circumstances.

I moved to North Valley due to parental neglect. It was decided I would benefit more by leaving my home in search of a better lifestyle and future. I now reside with my older sister, Cheri Estep. While I am also eligible to play swim, it was certainly not the primary reason for the move.

While I understand and support the rules and restrictions put into place by North Valley, I respectfully request that an exception be made due to the circumstances of my transfer.
