





If denied by the OSAA Eligibility Appeals Board, an appeal may be made to a Hearings Officer under Rule 8.11., "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$200.

My grandson, Ethan Scott Krupp, is a freshman at Crescent Valley High School.

Several weeks ago, Ethan, for reasons explained below, moved from Milwaukee, Oregon where he lived with his mother for a short period, back to Corvallis to live with me, his grandfather and guardian.

Ethans mother was a Meth addict and his step father was both verbally and physically abusive. It was at that point that my ex wife and I got guardianship of Ethan and he lived with us for 7 years..

This past summer, Ethans mother, now clean for 2 years, asked if Ethan could move up to Milwaukee to live with her, his two younger brothers and her boyfriend.
