If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I am writing on behalf of my daughter, Vanessa Jones. She was attending Mountain View High School up until last week, and is now at Trinity Lutheran School. She will most likely remain there through the rest of her high school years. Vanessa is a freshman this year.

Things started off well for her at Mountain View this year. She was getting good grades, seemed to have a good group of friends, and was active in sports. Her cross country team took 2nd at state, and she even lettered this year.

Once cross country ended, things kind of started to fall apart for her. Kids began to pick on her. A group of boys stole her cellphone and passed it around for over a month. She was being teased the whole time. Eventually the school called me and had found out who was responsible, but sadly her phone had been destroyed. iPhones are not cheap! My wife and I have very open communication with our daughter, so we did a lot of talking about the environment she was in at Mountain View. We were blown away to find out the things that kids are into these days, even at just 14 years old. In addition to the bullying that she was dealing with, the kids all around her were doing drugs, drinking, and having casual sex regularly. It was apparent to me that this was no place for my little girl. My fear was that she would overcompensate for being picked on, and (in an attempt to fit in) fall into the same traps that so many other kids were in. I was just not willing to take that chance so I pulled her out of Mountain View, and put her back in Trinity where she had attended grade school.

We love the Trinity family, and we know that we made the right decision for Vanessa. The one potential hang up, it seems, is her ability to play basketball. Now that she is at Trinity, she would love to be a part of the basketball team. It would give her the ability to compete and also help her to make some friends. I can't imagine it is easy switching to a new school in the middle of the school year and having to make all new friends. I understand that she could also continue swimming for Mountain View, but that is not an option as at least one of the kids on the swim team was a big part of Vanessa's problems there.

Please allow our daughter to start playing basketball for Trinity. She is an amazing girl and deserves the opportunity to take advantage of all that is available to her at her new school.
