Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.



Hello, my name is Samuel George Colgan I am a senior at Condon High School. I am writing to you because I wish to explain the situation and events that have brought me to Condon. The truth is I have been living with child abuse all of my life. Until last summer I always treated like something I just had to deal with or get through, but the moment I realized I had an escape I took it. My siblings and I spoke to DHS. At That moment I was in a strange situation, my siblings had a good life with my parents, they didn't know how it felt to be punched in the face repeatedly, Clawed, kicked on the ground, have someone choke you, even have someone run their fingers through your hair and have your head bashed against a wall. These terrible things and much more have all happened to me. I could keep this terrible list going but the physical abuse was easier for me to deal with since I could get back up and hold on to the idea that I wouldn't allow myself to give them the satisfaction of thinking they broke me. What truly troubles me and has throughout my child hood was being told how utterly worthless I was and how I will never amount to anything in life. Those phrases and many more still dig at me, it's painful but I'm trying to talk about these things and I have been getting help since I have moved to Condon. Some of you may know how it feels some of you may not, but it should be painfully clear how this makes a child feel. When I was finally awoken to how paranoid and afraid I had become, I was almost an adult. I couldn't wait until my birthday in October to move out of that house. So while there was an open investigation in to my family by DHS, I moved to Tualatin. I got a job and attended school. I learned something's about myself for better or worse. I got in contact with a family I had known for many years and asked them if I could spend my last year of high school in their home. Once I turned 18 I could finally go back to Condon without fear. I moved to Condon because that was the school I had attended from 7th grade to more than half way through my junior year. I was welcomed with open arms and I am grateful that I can be in a house that isn't perpetually hostile. The reason Track and Field is so important to me is because athletics have always been there for me. They have kept me safe in the past and my in my time participating in a love had grown for it. I'm sorry this has been a troubling subject for mem, but I would like to thank you for taking your time and reading this letter.


My name is Jennifer Bold, my husband and I currently provide a home for Samuel Colgan. He has been living with us since November 1, 2015. We would really enjoy seeing Samuel compete in track this year. He is a senior, an excellent student, with an admirable GPA as well as attending college classes.

My family has known Samuel for about 5 years. He has always been a polite, helpful and generous child. Over the course of his families stay in Condon we began to notice that things were not going well. The family had some DHS involvement as well as the Multi-Disciplinary Team assessing the family. As things were being recognized the family left the community. I spoke with the family extensively to request Samuel stay with us due to his extreme distress upon finding out they would be moving the next day. The family refused the offer in March 2015. Upon arrival at their new location DHS was once again involved. At that time Samuel disclosed that he and his siblings were being abused. The investigation by DHS was unsatisfactory to Samuel and he fled the home in June 2015.

October 2015 I was contacted by Samuel and asked if he could stay with us so he can finish high school. We immediately took him in. Samuel has extensive damage to his face due to repeatedly having his nose broken. We are currently seeking treatment for the repairs to be made to his face. He is an active boy and we encourage his participation in track for the 2015/16 school year. He has been a blessing to us and we are grateful to be able to provide him a safe landing place.

I implore you to consider granting the opportunity to Samuel and allow him to finish out his school year doing what he loves. Thank you for your consideration in this matter.



Sam attended Condon HS from his freshman year to March of his junior year, when he and his family moved to central Oregon and he enrolled in Crook County HS in Prineville. Sam finished out his junior year there. From my understanding, when the school year ended, there was a little upheaval in his family situation which resulted in Sam leaving home and moving to live with friends in Tualatin, Oregon. Sam got a job in order to raise some money to help out with the living situation that he was now in. In September, Sam enrolled in the Tigard-Tualatin On-Line Academy in order to continue his education for his senior year. In October, after turning 18, Sam transferred from the on-line school back to Condon HS, where he wants to earn his high school diploma! He is on track to do just that! He currently resides with a family that he knows well from his previous time in Condon.

Sam is a great kid and student! He is self-motivated, despite the circumstances of being away from his family. He very much wishes to participate in track this last year of high school. He is not a star athlete, but he is willing to work hard at doing his best and setting personal goals. Due to his current ineligibility status, he will be unable to participate in something that he has enjoyed doing the past couple of years at CHS. 
To Whom it May Concern-
