Can you please send this to the hardship committee for Cal Seneker. Cal is a student who attended Oregon Episcopal School in Portland but has played for pacer baseball as they do not have a team and this is his home school. Due to some recent changes and issues socially, his family has decided to remove him from OES and have him go to school in his home district.

Had Cal stayed at OES he would have been eligible to compete. Because he moved during mid-year to Lakeridge he is ineligible unless granted hardship by the TRL Hardship Committee. My hope is the TRL District committee will understand this situation as we have a young man who would have been able to play for Lakeridge had he attended another school.
