




If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

Hello, My name is Breanna Simmons.

I used to live in Laverne, Oklahoma before I lived here in Oregon. The reason behind why I have moved up here is because of my mom. I originally came up here just to visit for a few months, but then my mom had gotten arrested; again. She got arrested for drug use. She has been a drug addict for a while now and is just starting to work on being clean again.

When I lived in Oklahoma my mom was never really around because she was always working. So I thought that staying here with my aunt would be better for me, not only because my mom had been in and out of jail a lot and I would have been put into foster care while she was in jail, but also because I would always have someone around, like an adult. Because I decided to stay here I had to go into school because the start of the new school year was nearing. I was too shy and scared to start off at a public high school because I didn't really know anyone and didn't have any friends, so I figured I would try the Baker Early College program with my cousin, but I had signed up too late so I had to do their online program until the next semester. The online program ended up being too hard for me though. Having to sit at a computer all day was too difficult for me, and I am not very good with computers anyway. I would also get bored and distracted way too easily. Another thing is that getting ahold of the teachers for help was really difficult so I didn't understand a majority of the stuff I was doing, so more than often, I would just guess on my homework and test questions.

When I was finally able to start the Baker Early College program, I decided that I wanted to go to Ridgeview instead. I thought it would be the best thing for me to do, because, I would have face-to-face interaction with the teachers and I would also be able to make new friends. Now that I go to Ridgeview I would like to get more involved with sports. I think this will help me as far as making friends and getting more involved in the school.

My eldest daughter is apart of the Baker charter schools early college program, and my son Gregory was entering 9th grade at Ridgeview, so we gave Bre both options, she chose baker but it was too late to enter the college program that first semester so because she was nervous about going to a large school she chose the online program at Baker. Bre had a really hard time focusing and having to manage herself and when it came time to do early college she was behind struggling most of winter break to make up everything and so she decided to instead just go to Ridgeview. Now she would like to have the opportunity to play a sport.
