I have known Danica Stoelk for the past two and one half years. She has historically been a good student. School and grades are important to her. At the end of November 2015 Danica experienced a mental health crisis. She was subsequently hospitalized and received medication and intensive therapy.

Danica returned to school January 11, 2016. She has since been working with teachers to complete some first semester classes and has resumed a full schedule of classes for second semester.

Due to her mental health crisis, Danica lost credit for most of her classes first semester. The situation was not indicative of Danica's normal academic performance. She is currently doing well academically, attending regularly and has a plan in place should she experience symptoms again.

With a strong desire to attend college, Danica continues in the appropriate classes to prepare her for post-secondary education. She is currently on track to graduate with her class and plans to do so.

As her counselor, it is clear to me Danica is a young woman preparing for her future. She is more aware of her health and she has protocols for dealing with any possible future crisis. Danica should in no way be punished for a situation that was beyond her control.
