Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

Mikayla has been a student at Riddle School District from a very early age until she finished eighth grade. When it came time to enroll this year, she decided to follow in her sister's footsteps, and move in with her dad in Sutherlin, and enroll at Sutherlin High School. She was intrigued by rekindling a family relationship with her father and sister who she wasn't seeing as frequently as she would have liked. She was also excited about enrolling at a larger school with more kids, and more extra-curricular activities. Unfortunately for her the move did not go well. Mikayla quickly struggled to fit in. Her red hair became a target of boys and girls alike who were quick to point out her differences. Instead of dealing with this in a positive manner, Mikayla shut down.
