This was a move to protect my child from the Chiloquin Jr./Sr. High School Administrators. They have gone from suspending her from school for two days to kicking her off the basketball team. All of this was done based on one girl's lie. They did not bother to find out both sides of the story. We are still in the process of figuring out why all of this happened. My child has never been in trouble, she is a 4.0 student, and she does not drink, smoke or party. This is a kid who reads books in her spare time. And they said she is a troubled youth. I did not want them to mess with her academically because Kiya has plans to go on to college and will be applying for scholarships. I do not feel she would be safe there.

Moving her to Klamath Union is not easy for us. We have to drive 30 miles one way to get her to school in the morning and our car is not in the best condition mechanically. I am a single mother with one other child still at Chiloquin. She chose to stay so she would not mess up her graduation but if that were not the case she would have transferred too. Luckily, I do not have to be at work until 10:00 am so I have time to drive back and not be late. Then in the afternoon I have to turn around and pick her up at the end of the day.

She is a very athletic student. She likes Volleyball, Basketball, Softball and Track. She would like to continue participating in sports; we are hoping you understand why we had to transfer schools.
