If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

My name is Julia Stoner, and I am writing this on the behalf of my daughter Phoenix Jones. For the first semester of the school year, she was enrolled in ORCA. Due to delays in paperwork, she did not start until 3 weeks into the start of the year. There was also a delay in determining what Math class should have been assigned.

When the paperwork was completed and she was finally enrolled and assignments loaded, she was already 3 weeks behind on assignments. They also changed her math class twice and with each change, all the assignments that she would have had to do if she was enrolled from day one would load and she would have to start from the beginning. The final time they changed her math class, they were a month and a half into the semester and she was back at square one again.

During the first semester, things happened that also caused Phoenix to fall behind. In November, we moved to Lafayette.
