Any party filing an appeal of a decision made by the District Athletic Committee to the OSAA Eligibility Appeals Board shall be assessed a filing fee of \$100 to defray the costs to the Association of assembling the respective appeals bodies to hear the appeal.

If a waiver is denied by the OSAA Eligibility Appeals Board, an appeal can be made to a Hearings Officer under OSAA Handbook Rule 9, "Hearings Officer." Appeals to the Hearings Officer shall include an appeal fee of \$250.

I am writing to explain the situation for my Daughter, Jordan Coplin, DOB 8/12/1999 and her transcript from last year. Currently Jordan is a sophomore at Mountain View High School and is playing on the Tennis Team. In the late summer of 2014 before her freshman year Jordan went through a medical procedure to correct a heart arrhythmia. She began her freshman year at Bend High School in September of 2014. Then in October she developed a case of mono. She became critically ill with a severe case of mono while still recovering from the heart procedure. Based on her physician's advice we pulled her from public school and enrolled her in a home school program through Baker Web Academy. She completed her freshman year at Baker Web Academy and began her sophomore year this year at Mountain View High School.
